Operating Policy and Procedure

HSCEP OP: 51.04, **Access for Individuals with Disabilities**

PURPOSE: The purpose of this Texas Tech University Health Sciences Center El Paso (TTUHSC El Paso) Operating Policy and Procedure (HSCEP OP) is to ensure full and equal access to individuals with disabilities to all TTUHSC El Paso programs.

REVIEW: This HSCEP OP will be reviewed in November of each odd-numbered year (ONY) by the System Office of Equal Opportunity, the System Office of General Counsel, the Office of Human Resources, and Office of Student Services, with substantive revisions forwarded to the Office of the President.
